Welcome! These Terms of Service form an agreement between you and Playhouse Media LLC or, if you reside in the European Union, between you and Playhouse Media Trading Ltd. They cover the website available at SecretDesires.AI (the "Website") and the SecretDesires.AI mobile application (the "App"). In these Terms, "secretdesires.ai," "Company," "we," or "us" refers to Playhouse Media LLC or Playhouse Media Trading Ltd., as applicable based on where you reside, and "Services" refers to the Website, App, and any content, tools, features, and functionality offered through them.

These Terms govern your access to and use of the Services. Please read them carefully, as they include important information about your legal rights. By accessing or using the Services, you agree to these Terms. If you don't understand or agree to these Terms, please don't use the Services.

In these Terms, "you" and "your" refers to the user of the Services. If you use the Services on behalf of a company or other entity, "you" includes both you and that entity, and you represent and warrant that (a) you are an authorized representative of the entity with the authority to bind it to these Terms, and (b) you agree to these Terms on the entity's behalf.

Your Registration Obligations
